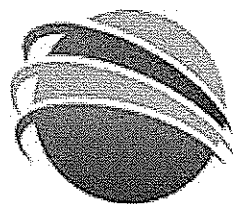

**A. Purpose and Funding:**

The stated mission of Hispanic Heritage Council of Western New York, Inc. (the Organization) is to foster and inspire awareness, understanding and appreciation of past, present and future contributions of the Hispanic community in Western New York. Hispanic Heritage Council of Western New York is currently being funded through public and private donations, grants and fundraising.

**B. Summary of Significant Accounting Policies:**

The financial statements of Hispanic Heritage Council of Western New York, Inc. are prepared on the accrual basis of accounting. Revenues are recognized as they are earned, and expenses charged when they are incurred. The following describes the more significant of those policies:

1. Contributions:

The Organization adopted SFAS No. 116, "Accounting for Contributions Received and Contributions Made", in accordance with SFAS, No. 116, and contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted support depending on the existence or nature of any donor restrictions. All restricted revenues, which meet such restrictions within the same period, are reported as unrestricted.

2. Contributed Services:

During the years ended December 31, 2022 and 2021, the value of contributed services, meeting the requirements for recognition in the financial statements, was not material and has not been recorded.

3. Advertising expenses:

The organization expenses advertising costs as they are incurred.

4. Financial Statement Presentation:

The Organization has adopted Statement of Financial Accounting Standards (SFAS) No. 117, "*Financial Statements for Not-for-Profit Organizations*". Under SFAS No. 117, the Organization is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

5. Cash and Cash Equivalents:

For the purpose of the statement of cash flows, all investments, with maturity of 90-days or less, are considered cash or cash equivalents. Unrestricted cash amounts to \$17,954 and \$7,115 at December 31, 2022 and 2021, respectively. The 2021 cash flow statement has been adjusted to show the actual cash and cash equivalents, without the addition of receivables.

6. Tax-Exempt Status:

The Organization is exempt from Federal income taxes under Section 501(c)(3) of the Internal Revenue Code.

7. Equipment:

Acquisitions of equipment and expenditures, for repairs and maintenance that materially prolong the useful lives of the assets, are capitalized. Equipment is stated at cost and is depreciated on the straight-line method using the expected useful life of three to seven years. Depreciation expense was \$1,234 and \$3,003 for the years ended December 31, 2022 and 2021, respectively.

8. Pervasiveness of Estimates:

The preparation of financial statements, in conformity with generally accepted accounting principles, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**C. Hispanic Heritage Cultural Institute:**

The Organization is in the process of building a Cultural Institute to promote the Hispanic culture of Buffalo and the Western New York Community. As of December 31, 2022, there are \$529,350 of unconditional promises to give recorded as revenue. Additional funding amounting to \$10,464,777 has been procured with conditions and not reported as revenue as of December 31, 2022. These will be reported as conditions are met. Additionally, \$5,300,000 in funding has been proposed and are awaiting budget approval. Funding allocated to this project are reported with donor restrictions and amount to \$1,164,416 and \$735,480 as of December 31, 2022 and 2021, respectively.

**D. Amortization:**

The company amortizes organization costs on the straight-line method. Amortization expense amounts to \$18 for the years ended December 31, 2022 and 2021.

**E. Concentration of Credit Risk:**

The Organization uses financial institutions in which it maintains cash balances, which at times may exceed federally insured limits. The Organization has not experienced any losses in such accounts, and management believes it is not exposed to any significant credit risk on cash.

**F. Subsequent Events:**

Events that occur after the balance sheet date, but before the financial statements were available to be issued, must be evaluated for recognition or disclosure. The effects of subsequent events that provide evidence about conditions that existed at the balance sheet date are recognized in the accompanying financial statements. Subsequent events, which provide evidence about conditions that existed after the balance sheet date, require disclosure in the accompanying notes. Management evaluated the activity of the company through June 16, 2023 and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.
